THESE ARTICLES OF ORGANIZATION (HEREINAFTER REFERRED TO AS THESE "ARTICLES") ARE MADE THIS 30<sup>TH</sup> DAY OF JANUARY, 2007, BY THE UNDERSIGNED; BEING AUTHORIZED TO EXECUTE AND FILE THESE ARTICLES.

EXPLANATORY STATEMENT

THE UNDERSIGNED, DESIRING TO ORGANIZE A LIMITED LIABILITY COMPANY UNDER AND PURSUANT TO THE PROVISIONS OF THE MARYLAND LIMITED LIABILITY COMPANY ACT (TITLE 4A OF THE CORPORATIONS AND ASSOCIATIONS ARTICLES OF THE ANNOTATED CODE OF MARYLAND) (HEREINAFTER REFERRED TO AS THE "ACT") HEREBY FORMS A LIMITED LIABILITY COMPANY FOR THE PURPOSE AND ON THE TERMS AND CONDITIONS HEREINAFTER SET FORTH (THE COMPANY), AND HEREBY CERTIFIES TO THE MARYLAND STATE DEPARTMENT OF ASSESSMENTS AND TAXATION AS FOLLOWS:

FIRST: THE NAME OF THE COMPANY SHALL BE :

JUST-FOR-U TRANSPORT, LLC

SECOND: THE COMPANY SHALL HAVE A PERPETUAL EXISTENCE.

THIRD: THE PURPOSES FOR WHICH THE COMPANY IS FORMED ARE AS FOLLOWS:

- (a) TO CONDUCT, OPERATE, AND MAINTAIN THE BUSINESS OF PUBLIC TRANSPORTATION AND HAULING, AND TO PROVIDE FOR SUCH TRANSPORT OF THE GENERAL PUBLIC AND/OR ANY LEGAL CARGO OF ANY INDIVIDUAL, BUSINESS OR INSTITUTE BY MEANS OF ANY VEHICLE ADEQUATE FOR THE PROVISION OF SUCH TRANSPORT WHETHER CONTRACTED BY SAID INDIVIDUAL, BUSINESS, INSTITUTE, OR ASSOCIATION OR BY ANY LEGALLY ASSIGNED REPRESENTATIVE THEREOF.
- (b) TO OWN, OPERATE, LEASE, PURCHASE AND SELL REAL AND PERSONAL PROPERTY;
- (c) TO ENGAGE IN INVESTMENT ACTIVITIES;
- (d) TO HAVE AND EXERCISE ALL POWERS NOW OR HEREAFTER CONFERRED BY THE LAWS OF THE STATE OF MARYLAND ON LIMITED LIABILITY COMPANIES FORMED PURSUANT TO THE ACT; AND
- (e) TO DO ANY AND ALL THINGS NECESSARY, CONVENIENT OR INCIDENTAL TO THE FOREGOING ENDEAVORS.


